Notice is hereby given that the Kern Community College District (OWNER) will receive sealed bids for **Bakersfield College Administrative Services Project**.

All bids must be received at the Kern Community College District Office, 2100 Chester Avenue, Room 201, Bakersfield, CA 93301 by 11:00 a.m. on Thursday, February 4, 2021 and will be publicly opened at or after that time.

A non-mandatory Job Walk will be held on Thursday, January 14, 2021. Due to COVID-19, two (2) time options are offered at 8:00 a.m. and at 10:00 a.m. at 1801 Panorama Drive, Bakersfield, CA 93306. Meet in front of the main entrance to the existing Administrative Services Building. The Plans and Specifications, including standard proposal forms, to be used for bidding on this project are available at Blueprint Service Company (<http://www.blueprintservicenet.com>), 1100 18<sup>th</sup> Street Bakersfield, CA 93301 (661) 327-2501 or through Kern County Builders' Exchange, Inc (<https://www.kcbex.com>). No bid will be considered unless it is made on the bid form furnished by the District. This is a prevailing wage project. OWNER has ascertained the general prevailing rate of per diem wages in the locality in which this work is to be performed for each craft or type of worker needed to execute this contract.

These rates are on file at OWNER'S office, and a copy may be obtained upon request, or at [www.dir.ca.gov](http://www.dir.ca.gov). It shall be mandatory upon the contractor to whom the contract is awarded (CONTRACTOR), and upon any subcontractor, to pay not less than the specified rates to all workers employed by them in the execution of the contract.

This Project is subject to the requirements of Subchapter 4.5 of Chapter 8 of Title 8 of the California Code of Regulations. Contractor and all subcontractors must furnish electronic certified payroll records to the Labor Commissioner, weekly, using Department of Industrial Relations' eCPR system <https://www.dir.ca.gov/Public-Works/Certified-Payroll-Reporting.html>.

The following notice is given as required by Labor Code Section 1771.5(b)(1): CONTRACTOR and any subcontractors are required to review and comply with the provisions of the California Labor Code, Part 7, Chapter I, beginning with Section 1720, as more fully discussed in the Contract Documents. These sections contain specific requirements concerning, for example, determination and payment of prevailing wages, retention, inspection, and auditing payroll records, use of apprentices, payment of overtime compensation, securing workers' compensation insurance, and various criminal penalties or fines which may be imposed for violations of the requirements of the chapter. Submission of a bid constitutes CONTRACTORS's representation that CONTRACTOR has thoroughly reviewed these requirements. The District will utilize a multiple prime contractor delivery method to complete Project construction. In order to perform the work required by this contract, CONTRACTOR must possess the following type of license/certification issued by the State of California as separated by Bid Package number: #01, Demolition & Hazardous Material Abatement (A or C-21 and C-22), #02, Earthwork, Concrete, AC Paving & Striping and Masonry Repair (A or B), #03, Plumbing (C-36), #04, HVAC & Controls (C-20), #05, Electrical & Low Voltage (C-10), #06, Roofing & Sheet Metal (C-39), #07, Structural Steel and Ornamental Metals (C-51), #08, Metal Stud, Wood Frame, Drywall, EFIS, Plaster & Insulation (B or C-35 and C-09 and C-02), #09, Curtain Walls, Aluminum Framed Entrances, Storefronts, Glass & Glazing (C-17), #10, Doors, Frames and Hardware (B or C-61/D-28), #11, Painting & Vinyl Wall Coverings (C-33), #12, Casework, Cabinetry and Countertops (B or C-06), #13, Acoustical Ceiling and Fiberglass Reinforced Wall Panels (C-02), #14, Ceramic Tile (C-54), #15, Flooring (C-15), #16, General, Architectural Specialties (B), #17, Final Cleaning (C-61/D63)
