Notice is hereby given that the Kern Community College District (OWNER) will receive sealed bids for Bid No. 03- 119810 **Cerro Coso Community College ESCC- Bishop Parking Lot Rehabilitation.**

All bids must be received at the Kern Community College District Office, 2100 Chester Avenue, Room 201, Bakersfield, CA 93301 by 3:00 p.m. on 2nd day, April, 2020 and will be publicly opened at or after that time.

A Mandatory Job Walk will be held on 16th day, March 2020 at 1:00 p.m. at Easter Sierra College Center Bishop 4090 W. Line St, Bishop, CA 933514-7306. All plans will be sent electronically. The Plans and Specifications, including standard proposal forms, to be used for bidding on this project are available electronically from Cornerstone Engineering Inc, contact Alan Whitten at 661-325-9474 or caw@cornerstoneeng.com or ebidboard.com. No bid will be considered unless it is made on the bid form furnished by the District. This is a prevailing wage project. OWNER has ascertained the general prevailing rate of per diem wages in the locality in which this work is to be performed for each craft or type of worker needed to execute this contract.

These rates are on file at OWNER'S office, and a copy may be obtained upon request, or at www.dir.ca.gov. It shall be mandatory upon the contractor to whom the contract is awarded (CONTRACTOR), and upon any subcontractor, to pay not less than the specified rates to all workers employed by them in the execution of the contract.

This Project ___ is **X** is not subject to the requirements of Subchapter 4.5 of Chapter 8 of Title 8 of the California Code of Regulations. If subject to such requirements, Contractor and all subcontractors must furnish certified payroll records to the Department of Industrial Relations' Compliance Monitoring Unit (CMU) [specify weekly, bi-weekly or monthly] using the CMU's eCPR system – My LCM. These sections contain specific requirements concerning, for example, determination and payment of prevailing wages, retention, inspection, and auditing payroll records, use of apprentices, payment of overtime compensation, securing workers' compensation insurance, and various criminal penalties or fines which may be imposed for violations of the requirements of the chapter. Submission of a bid constitutes CONTRACTOR'S representation that CONTRACTOR has thoroughly reviewed these requirements. In order to perform the work required by this contract, CONTRACTOR must possess the following type of license/certification issued by the State of California: A,B, C12.
